- Item 1 Call to order. Cliff Seidel called the meeting to order at 7:44 PM.
- **Item 2 Approval of minutes of the June 16, 2016 meeting.** Winker moves to accept. Rogers' second motion passes.
- **Item 3 Fill the vacant board seat.** Rogers' moves that Silas Powell be nominated to fill the seat left open by Sue Lane. Winkler seconds. The motion passes. Powell's term ends Feb 2017.
- **Item 4 Treasurer's Report.** Winkler discusses the issues of the bank account. Brenda distributes copies of a repost showing fund totals and reminds the group we still have outstanding bills of \$20 -25,000. Winkler will change the account numbers on the FNB accounts. (See report attached.) Rogers moves to accept treasure report. Powell seconds and the motion passes.
- **Item 5 Architectural Control Committee Report.** Rosales of ACC has been working on documents to note fees, schedules, fines and guidelines. No motion was taken.
- Item 6 Old Business. Discuss and take possible action on old business.
- **A. Bookkeeper contract status.** Winkler will gather bids on handling the POA accounts. Winkler hopes to have her findings to bring back to the board by the next meeting.
- **B. PO Box.** Rogers' moves to change our PO Box to a mail center. Powell moves to change the POA mail to Mail & Sign and generate a change of address from the current PO Box. Winkler seconds and the motion passes.
- **C. Status on Tax return for 2015.** We have filled for another extension. Rosales agrees to sign the tax return as a board member from 2015. We were informed the old board owes money dating back to 2013.
- **D. Status on Audit.** Winkler makes a motion to conduct an audit. She will work with our current CPA to determine the scope of the audit. No motion was passed.
- E. Status of redesigning of the POA website. Rosales is working to learn how to use it better. Rosales will get bids on a new website.
- F. New trial date: Sept 22, 2016.
- **G. Unit 6 Locks.** The board needs to get locks for the new signs in Unit 6. Rogers motions to purchase four (4) locks with a budget of \$150. Rosales seconds and the motion passes. Powell says he will take care of the lock purchases.
- H. Meyers Resignation. Cynthia Meyers resigned from her position on the ACC.
